

### Clinical academic pay scales (Scotland) from 1 April 2023

#### 1. Summary of changes

The pay scales for medical and dental consultants have been uplifted by 6.0% to basic pay. The pay scales for doctors and dentists in training have been uplifted by 12.4% to basic pay.

The values of distinction awards and discretionary points for consultants are unchanged from last year.

#### 2. Transitional pay arrangements

The transition period for staff holding honorary consultant contracts who transferred to the 2004 consultant contract under the provisions of paragraphs 14.2.3, 14.2.4, 14.2.6 of the terms and conditions of service for consultant grade staff in Scotland has ended. Table 8 has not therefore been updated.
