

# Showing us evidence of your submitted visa application

If you have submitted a visa application and you are waiting for it to be processed by UKVI, you will need to provide us with a copy of the application form or supporting document checklist.

You can download one of these documents by logging into your visa application. To do this, find the email you received at the time you submitted and paid for the application online, and then log in with your password.

## Evidence

Occasionally, UK Visas and Immigration (UKVI) may request this evidence while your application is being considered. If the evidence is requested, your visa application may be refused if you do not provide it.

You should use your supporting documents checklist as a guide to what documents you need to self-upload or take to your appointment.

You will be able to upload copies of your documents on our commercial partner's website, or you can take your documents to your biometrics appointment to be scanned and uploaded by our commercial partner for a fee. You do not need to send any physical documents to the Home Office or UK Visas & Immigration unless you are advised to do so.
